2.3 Policy for Endowment fund

At present there are no policy related to receiving endowment fund by the Institute / Department. Few philanthropic organization/ Individuals have approached the Institute for starting meritorious award in the name of their parents/family member. In the absence of any policy, the Institute is not able to receive fund for various meritorious award. A draft endowment policy has been attempted and shall be presented in the 12th BoG.

3.3 Implementation of NEP 2020

A committee has been constituted the Chairman BoG to prepare the roadmap for implementation of NEP in DBRAIT. The First meeting of the committee was held on 24th April 2021 and the minutes of the meeting is attached at **Annexure-III** (page no. 31-36.) of Agenda note. Following actions have been taken consequent to above meeting.

- 1. Webinar on NEP organized which was participated by 90+ students and faculties & 10 resource person from the institute were roped in.
- 2. The girls students were sensitized about various AICTE scholarships and 10 students selected for PRAGATI scholarships.
- 3. A comprehensive study of the University curriculum was carried out and compared with the relevant NPTEL curriculum around 30% of subjects of different curriculum has 80% of common topics with NPTEL. Hence, a scheme has been formulated to encourage students to register in NPTEL. The gist of the scheme is as under:

- (i) The NPTEL courses where the content matching score is more than 40% should be selected by the subject teacher along with the regular curriculum subjects (particularly for GREY SUBJECTS where previous results are less than 60%). Care must be taken that the pre-requisite criteria are met based on the students' learning so far.
- (ii) The teacher who takes Computer Programming for first semester BTech (CSE/CIVIL) and enroll for NPTEL course should also be given Computer Program for B.Tech (ECE) in the second semester.
- (iii) A NPTEL course thus selected should be registered and enrolled for exam by the students and the faculty as a course mentor unless the faculty has already successfully completed the course. The faculty should guide and check with the students to attempt all the assignments of the enrolled course.
- (iv) Atleast 01 courses on Emerging Trends/ Future Skills / Market Driven technologies offered by NPTEL-MOOCS should be compulsorily insisted for enrollment for certification in 3rd or 4th years.
 - (v) NPTEL course mapping with GATE curriculum has to be carried out and courses which are covered in GATE should compulsorily be enrolled starting from 3rd year onwards.
 - (vi) Subjects identified to be offered in the current semester (except GATE subjects identified in Sl. No 4) should be circulated among other faculties who have taught those subjects in past for obtaining concurrence on content similarity.
 - (vii) In order to motivate students for taking up NPTEL courses, various incentivization measures has been identified-

Status on Rain Water Filter unit and on IWRRC

Rain water harvesting project has been taken up to make the campus self-sufficient in water and to solve the water crisis during dry seasons. The campus has been divided into 6 clustures. 1 to 5 clusters would be provided with rain water harvesting tank and the water from the 6th cluster would be diverted to the pond created near the auditorium is 14,388,170 litres and the capacity of tank proposed near academic block is around 5,48,025 litres.

The IWRRC has covered more than 75% of gram panchayat together for South & Middle Andaman district with GIS survey of existing water resources and completion of detailed project report for individual panchayats. The design and function of rain water filter unit 'Ritu-Karotar' has been developed by IWRRC & its implementation was discussed with Chouldhari Panchayat. Chouldhari Panchayat agreed to install 'Ritu-Karotar' in 10 households to promote and popularise the practice of rain water harvesting and its utilisation for household purpose.

IWRRC also provided GIS Mapping (Data Corrections) for APWD sources of every tehsil of A & N Islands. This GIS data conversion allows data from different sources to be merged in one common format, which allows for easy access, analysis and utilization like Mapping, Agricultural Applications, and Surveying etc.

Decision:

The BoG noted the progress of various ongoing projects.

The BoG gave consent for the DST project jointly being done with IIT Madras. The BoG further appreciated the institute being selected us one of the Co-Principal Investigator for one of the DST Sponsored Project on Brackish/ Seawater desalination project to be submitted by IIT- Madras as the Principal Investigator (PI) institute, IIT-Delhi (Co-PI) and NIT Pondicherry (Co-PI) institute and DBRAIT (Co-PI), wherein centre of excellence shall also be established in the institute as part of the proposed project.

3.6 Status on Affiliation

Pondicherry University not yet communicated affiliation to the B.Tech Programs for the Academic year 2021-22 whereas the last date for grant of affiliation to Institution with University was 3rd September, 2021 as notified by AICTE. Due to delay in grant of affiliation the admission process for the academic session 2021-22 could not be initiated which has created a state of concern for the aspiring students of these remote islands.

Decision:

The Chairman BoG suggested that since the matter is in subjudice, the board shall refrain from making any comments.

3.7 Result Analysis & Academic Audit

It has been observed that there has been a gap in the documentation requirements at the department/faculty level as required for the outcome based education under the latest formats of NBA/NAAC.
