- The Recruitment Notice was published in national daily and was re-advertised to get more eligible candidates.
- The Selection Committee was constituted as per AICTE norms and interviews were held at Chennai and Bhubaneswar. Two Associate Professors one each for Civil and CSE were recommended by the selection committee.
- · The proposal was sent to NPIU with the approval of Chairman, BoG, the NPIU forwarded the same to Secretary (Edn), A&N Administration
- A&N Administration has taken action to obtain approval from competent authority for issuing the offer of appointment followed by appointment letter.
- Since no eligible candidates for 3 Professors (Civil, CSE and ECE) and 1 Associate Professor (ECE) were found in the earlier advertisement, the vacancy notice was published again and 7 eligible candidates were shortlisted.

Root cause of poor results in degree programs:

✓ Absence of professional counseling and low cut off marks for admission (38% to 42%).

- ✓ The RFT in last 03 years have been in the range of 2% to 20% in degree programs and transition rate is 100% since 100% backlogs are allowed by Pondicherry University.
- The RFT for diploma programs ranges from 9% to 16% and the transition rate is 25-63 %.
- Absence of proactive approach and motivation in teachers.

Recommendations:

- ✓ To introduce entrance test/JEE qualifying exam at entry level to improve the quality of intake for both diploma and degree.
- ✓ Filling of vacancies on Priority and recruiting experienced faculties through NPIU.
- Conducting centralized internal exams to make the students have serious approach for academics.
- ✓ To introduce bridge courses in basic subjects to improve RFT and transition rates.
- ✓ To implement aggressive equity initiatives by engaging subject experts from coaching centres/Mentor institute/INIs for improving academic result.

Discussion & Decision:

 During the discussion it was suggested that to improve the results of basic subjects like Mathematics, Physics etc, bridge courses should be given to the identified target group from the beginning of the semester.

- BoG entrusted Shri Vinod Kumar, AP(ECE), Member of BoG to coordinate with all the regular faculty members and plan bridge course identifying grey subjects (subject having results less than 50%) and prepare schedule for the ensuing semester and submit to Dean (Academics) by end of January 2020.
- To invite faculties from coaching institutes/Centres for conducting special equity classes to improve the results on payment basis as per the guest lecturer norms.
- Retired faculty members of good institutes may be engaged for short term basis for teaching specialized subjects to improve the results and exposure of students.
- 4. DBRAIT may take up the matter with Pondicherry University to consider the number of backlog subjects allowed, to students, as followed in various other Central/Affiliating Universities.
- 5. BoG recommended a selection test for the admission to degree and diploma program from the year 2020 so that candidates who are serious in pursuing technical education are given opportunity. It was also recommended that from 2021 JEE score may be taken as criteria for admission in various B.Tech courses.

5.2 Affiliation issues with Pondicherry University

The BoG was appraised that Pondicherry University vide letter dated 07/11/2019 granted conditional affiliation for 03 B. Tech Programs for 3 months.

It was also informed that following issues were raised by the University in their above letter:

- A & N Islands Administration shall constitute an Enquiry Committee on the functioning of the College and the faculty complaints against the present Principal and submit a report within 8 weeks. The Enquiry Committee should consist of two University Nominees and one nominee of Andaman & Nicobar Administration.
- ii. As per the AICTE recent letter dated 23.10.2019 sharing the space, faculty and facilities of the Engineering College should not be permitted with Polytechnic College or any other institutions located within the same permission. Faculty recruited by UPSC for Engineering College should not be given teaching workload in Polytechnic College and vice versa.
- A qualified Principal as per the AICTE norms should be appointed within three months.
- iv. The Board of Governors (BoG) of the college should be reconstituted as per the AICTE norms and include two University nominees are to be invited to all the Meeting by giving sufficient time and notice.


